Motion by Mueller, second by Blaser to accept the bid from 4 Seasons Disposal for \$4,504 for the lot of dumpsters, motion carried. Motion by Pecha, second by Mueller to accept the bid from Engebretsen Bros. LLC for \$1,201.01 for the snow blower attachment, motion carried on a roll call vote.
