1. Hiring Clerk Treasurer Assistant

Motion to hire Chelsea Henkel as Clerk Treasurer Assistant with an official start date of 4/28/2016. Points of discussion are as follows:

One day off a month for work for HSHS Pharmacy and hours will be made up with compensation time. For 2016 there will be 32 hours of vacation as per code book, 4/28/2017 she will be considered a third year employee due to working part time for six years and receive 80 hours of vacation time. §16-161 Sexual Offender Residency Restrictions

B. (2) Designated Offender. Any person who is required to register under Wis. Stat. §304.45 for any sexual offense or any person who is required to register under Wis. Stat. §301.45 and who has been designated a Special Bulletin Notification (SBN) sex offender pursuant to Wis. Stat. §301.46(2) & (2m). §16-161 Sexual Offender Residency Restrictions

C. (1) Prohibited Location of Resident. It is hereby repealed and recreated as follows: It is unlawful for any designated offender to establish permanent residence or temporary residence within 1,500 feet of any school, licensed day care center, park, trail, playground, place of worship, or any other place designated by the City as a place where children are known to congregate.
