*§16-161 Sexual Offender Residency Restrictions*

*B. (2) Designated Offender. Any person who is required to register under Wis. Stat. §304.45 for any sexual offense or any person who is required to register under Wis. Stat. §301.45 and who has been designated a Special Bulletin Notification (SBN) sex offender pursuant to Wis. Stat. §301.46(2) & (2m).*

*§16-161 Sexual Offender Residency Restrictions*

*C. (1) Prohibited Location of Resident. It is hereby repealed and recreated as follows: It is unlawful for any designated offender to establish permanent residence or temporary residence within 1,500 feet of any school, licensed day care center, park, trail, playground, place of worship, or any other place designated by the City as a place where children are known to congregate.*
