Minutes

Tuesday, April 21, 2015

Mayor Irene Drake called meeting to order at 6:00 pm.

Present were Alderpersons Deborah Erickson, Marie Blaser, Nanette Mohr, Terry Nelson, William Pecha, and Marilyn Mueller. Also present was Mayor Drake and Clerk Beth Rank. Public present was Jeff Warrichaiet and Leone Christensen.

Council informed that the open meeting law had been complied with and roll call was taken.

Motion by Erickson, second by Blaser to approve Resolution #3-2015, setting the treasurer, deputy treasurer, and office assistance bond, motion carried on a roll call vote.

Motion by Mohr, second by Nelson to approve Resolution #4-2015 setting the official depositories, motion carried on a roll call vote.

Discussion was had on setting the official newspaper. Council directed Clerk Rank to look at pricing and circulation of the Time Herald and the Oconto County Reporter.

Motion by Nelson, second by Erickson to elect Mohr as Council president, motion carried.

Discussion was had on committee recommendations. Nelson felt it was a conflict of interest to have Blaser as head of HPL and that Pecha should be on HPL as he has the experience. Drake stated based on the attorney opinion it would be a policy decision to have Pecha on the HPL committee. Motion by Mueller, second by Blaser to approve the council committee recommendations, motion carried with Nelson voting nay.

Motion by Erickson, second by Blaser to approve the Tourism & Marketing Commission recommendations, motion carried with Mohr abstaining.

Motion by Nelson, second by Erickson to approve the Community Development Authority recommendations, motion carried with Mohr and Mueller abstaining.

Motion by Mueller, second by Blaser to approve the Library Board recommendation, motion carried with Mohr abstaining.

Motion by Nelson, second by Mohr to approve the OCEDC recommendation, motion carried.

Motion by Pecha, second by Mohr to approve the Sexual Predator Committee recommendation, motion carried.

Motion by Mohr, second by Mueller to approve the Utility Committee recommendation, motion carried.

Motion by Mohr, second by Blaser to approve the Weed Commissioner recommendation, motion carried.

Motion by Erickson, second by Pecha to approve the Board of Review recommendation, motion carried.

Motion by Mohr, second by Erickson to approve the Zoning Board of Appeals recommendation, motion carried.

Motion by Blaser, second by Mohr to approve the Police & Fire Disciplinary Review Committee, motion carried with Pecha voting nay.

Motion by Mohr, second by Blaser to approve the Ambulance Board recommendations, motion carried.

Motion by Nelson, second by Mueller to approve the official signees for the depositories as Mayor, Council President, Clerk, and Deputy Clerk, motion carried with Mohr abstaining.

Discussion was had on the building plans for 137 E Main St. Motion by Nelson, second by Pecha to approve the building plans at 137 E Main St contingent on the City receiving state approved plans and with the sprinkler system being looked at, motion carried.
