COMMITTEE MEETING  
June 10, 2015  
Health, Protection, & Licensing Minutes

Aldersperson Blaser called the meeting to order at 5:30 pm. Present were Alderspersons Marie Blaser, Deborah Erickson, Nanette Mohr, Marilyn Mueller, and William Pecha Also present were Mayor Irene Drake, Police Chief Jess Keplinger, and Clerk Beth Rank. Motion by Mohr, second by Erickson to approve a Special Class "B" Retailers' License for the sale of Fermented Malt Beverages for the Gillett Civics Club for July 3 – 5, 2015, motion carried.

Discussion was had on creating a bee ordinance. It was decided that Blaser and Erdmann will work on creating an ordinance to present to the committee.

Discussion was had on the parade route set-up and take-down. Public Works would like the Police Department to take care of the set-up and take-down. It was decided that the Police Department should not take care of the set-up and take-down because they are busy with other things and they may get called out on a case. This issue will be presented to the Public Works committee.

Discussion was had on the Police Department overtime. Currently they have \$2,555.62 in overtime with a budgeted amount of \$7,000.00.

Discussion was had on the Police Department hours of labor. Erickson questioned how many 12 hour shifts could be worked in a row. Clerk Rank looked into this and an employee can work as many 12 hour shifts as they want. Rank asked if Blaser looked at the State Statute 62.13(7n) regarding Police Department Hours of Labor. Blaser stated that she talked to the City Attorney regarding this Statute and the Attorney will write an agreement up to be in compliance with this Statute. Blaser stated if the City didn't want to have an agreement written up, then the Police Department may choose to have a union. Drake stated there could have been an agreement in the past but it may have disappeared. This topic will be on the next agenda.
