2. Update regarding OEC Problem

The week of Febrauary 15, 2016, there were a lot of problems. Schroeder had Troy from CTW looking at the voltage. Schroeder contacted OEC and it was disconvered that a regulator on Shawano Line Road was faulty. Since the regulator has been fixed, there have not been any problems.

3. VFD and Wiring of Lift Station at Waste Water Treatment Plant

Schroeder suggested leaving the VFDs at this time but would like to look into the wiring of the Lift Station. Schroeder and Nunn will look into bids for the cost of the wiring.

4. Problem at Well 4

The pump is out of the hole. There is an additional 150 feet of extra column pipe. The Column pipe and shaft will be saved for future projects. The pump is being set at 100 feet. The section of shaft needs to be replaced throughout the pump. The televising went well. CTW will start cleaning and the pump will be replaced next week with a pump test after. The chlorinator was leaking chlorine and is out to be fixed also. This should be returned around the second week of April.

5. Easement with Seneca Pipeline

Seneca uses City water to cool their cans and then the water is put into Christy Brook. The

DNR has changed the regulations of water that can be placed into the water and the water is now too high in phosphorus. The DNR suggested to Seneca to run a pipeline down to the Oconto River (under Christy Brook, through the ATV/Snowmobile Trail, across Quarterline Road). Attorney Schimd can get something (Mayor Drake was not sure of the name) to allow Seneca access to the trail. This project needs to be completed by 2018 and Seneca would like to start in 2017. Nunn asked where Seneca is planning to place their pipe in proximity to the sewer main. Drake was unsure but would talk to Mike Hull and ask Hull to have Seneca's engineers call Nunn.

If the Utility does not want to charge any vacant lots, the money collected from those lots needs to be distributed amongst all other lots. The committee will have a meeting with the Building Inspector to try and figure this out.
