4. Discussion and Possible Action on renaming North Wallis Ave.

The city has two North Wallisø that are not directly across from each other. The county said we can rename the street; we have to send all new information to them.

Motion to rename North Wallis behind Pat's Market calling it North Market Avenue.

Voice Vote: All voting aye. ó **MOTION CARRIED**

5. Discussion and Possible Action on moving storm water out of Savage Lake

Discussion and review of different options for storm sewer options: vortex, big box, gate. A gate could downsize the water going into the lake; a vortex would clean all water going into the lake. A valve could stop all water unless there was a huge storm (city could open valve to lake). Funding from USDA for any projects is on hold and no decision needs to be made.

6. Discussion and Possible Action on Road Construction Projects

We Energies is ready to move the poles on the streets we had projects on, with funding on hold, the decision will not be made until September if they need to be moved or not. Birch should be done to use our LRIP Funds. No action taken.
