Alderperson Mohr reported that the library is looking for a part-time person as Melissa is leaving. The position is for a library aid/cleaning for 23 hours per week. The wreath hunt finished yesterday and 18 families participated and were awarded prizes. Outside pergola project is at a stall due to no students in the building trades class this next semester. Kay is working with the teacher to get the project wrapped up. The library meetings will now be on Wednesdays instead of Thursdays to allow more participation by board. 11. **Fire Department Report:** Chief Hicks

- a. Discussion on Training, Public Relations, and Incident Summary Report ó Chief reported that they had a lift assist call on the 25th, power line down on the 18th, and another lift assist call on the 1st. For the year the department had 45 total calls of which 12 were false alarms, 4 mavis calls, 8 lift assist calls, 2 calls to assist with snow removal on barns, 3 gas meter calls, 1 call to assist Oconto Falls, 2 carbon dioxide checks, 1 traffic call, and 1 structure fire call. Upcoming training for the next three months will be with Underhill and the donated burn house in the township. New firefighter training will be conducted next month. The department is currently finishing up the lettering and striping on the trucks. The department purchased new helmets and ordered 4 new sets of turnout gear. Two new members were recently voted into the department which now they have a roster of 24 firefighters.
