3. Discussion and Possible Action on Garbage Pickup for 2021

*The Public Works Committee voted and approved containers for pickup of garbage for 2021. The committee selected and approved GAD as the preferred vendor after review of handouts provided by Ron Anderson, Head of Public Works and a discussion by all in attendance. See Public Works minutes dated 11.17.2020.*

*After some continued discussion, the Council concurred with the Public Works decision. Motion to contract with GAD for the 2021 garbage pickup using containers with an effective date of 01.01.2021.*

*Further logistics and fees/cost would be worked out at the next meeting.*

*There was further discussion on the possibility of some savings at the recycling center now that residents will have more capacity for recyclables and garage using the containers. Ron Anderson stated that we should monitor volume and activity until June or July and determine if schedule changes would be necessary for the center. Garbage pickup will be on Tuesday as it is now. Both recycling and garbage will be pickup weekly at the same time.*

**Roll Call Vote:** Those voting Yay were- Stroik, Spaulding and Rudie. Nays were Blaser and Hubbard. **MOTION CARRIED and Containers were approved with a final vote of 3-2.**

4. Discussion and Possible Action on Payment of BOND Maturity on 12.1.2020 –

A motion was made to approve the payment of the maturing BOND on 12.1.2020 in the amount of \$110,000 from the City general account following payment of the shared revenue funding.
