Public Input-Linda Hougas stated all the club members are here for the open discussion on the park rental fee and special event fee and have questions. She stated all the clubs give back to the community and the charges went up to use the facilities, now we charge for event, setup, takedown, cleanup, etc., concerned because they need to rent the fair building and then on top of that rent the park- it will take away all proceeds. Stated the clubs should have been notified of the parks meeting when the charges were changed.

Gillett Area Chamber Chris Byars asked about putting in sign posts with QR codes for phone and app updates, asking permission to put posts in.

Todd Carlson Civic Club said they have a great group of people and donate a lot of time; the fees seem to be rising tremendously. Setup fee is not fair because the setup is done early, 100 dollars a day for 8 days is alot. Lisa Sorlie said the money goes back to the community, balancing budgets is a tough thing, but what is the mission of the city? Gillett Historical Society is an offsite event, does this fee include them? Micki Carlson Fourth of July is concerned about not being able to use the cones and barricades.

Mayor will talk to Public Works about cones and barricades, to change the procedure of not lending them out to events to rentals or similar. Clubs asking what our mission is with this change, stated there is a growing distrust between the clubs and the city government. Byars stated the event members should have been invited to discuss before the decision was made. All decisions are made in committee then sent to council, the guidance we receive from our department heads is where we trust because they work with the issues every day. We solve problems that come to us and try to take all into consideration. Mayor stated our mission statement. Committee will discuss a division of the park for a different fee schedule in the park rental fees. Will review the park rental agreement. Debbie Woods said the Oconto County Fair maintains their buildings beautifully, and they should not have to pay for our park upkeep. Stated the answer is working together. Asked us to look into grants for maintenance and new equipment.
