The keeping of poultry hens shall be permitted subject to the following conditions:

- (1) No person shall keep any rooster or other fowl.
- (2) No person may slaughter any hen.
- (3) No sale of eggs or chicks
- (4) Hens shall be provided with a covered enclosure and kept in a covered or fenced enclosure all the time. Hens must be confined and are not allowed to run loose.
- (5) No permanent enclosure may be closer than twenty-five (25) feet to any residential structure on adjacent lots and no closer than three (3) feet to any lot line and must be located in the rear yard
- (6) Owner shall obtain a license from the city and provide proof of premise registration with the Wisconsin Department of Agriculture, Trade and Consumer Protection
 *** License can be pulled immediately for any violations. Permit fees will not be prorated. Permits are nonrefundable.



- 1. Your neighbor (applicant) is applying for a permit to keep chickens on their property. The City of Gillett requires written consent from neighboring property owners whose parcel boarders the applicant's parcel.
- 2. By signing this form **you are providing written consent** for the issuance of a permit to keep chickens.
- 3. See City of Gillett Ordinance Chapter 6 for complete rules and regulations.
 - a. Maximum 6 hens
 - b. Coops/Runs shall be min. 25' to dwellings and min. 10' to property lines
 - c. Chickens shall not be allowed to free range
 - d. Adequate coops, runs, food, water shall be provided at all times.
- 4. Any complaints received by the City may result in revocation of this permit or denial of renewal.
