This past week I attended a site security and safety evaluation of the Gillett School District Campus hosted by the Gillett School District Administrative team. Topics discussed included a review of the recent bomb threat response, security protocols for student drop off areas, improving external signage of buildings, updating labeling of interior rooms, and addressing security concerns for school events held outside of normal school operating hours.

Officers Hoeft and Buettner attended a free training event provided by the Wisconsin Department of Justice and hosted by the Oconto County Sheriff's Office. The topics covered included suspicious death scene and abuse investigations and updated investigatory processes for suspicious deaths and abuse of children. We are very fortunate to have this type of advanced training available to us in this area. As always we appreciate the Oconto County Sheriff's Office for including us in these training opportunities.

This month we will be taking part in the annual Oconto County Law Enforcement spring tactical training day, happening in Oconto Falls. Topics being covered are; MRAP Driver Operations, Ballistic Shield Entry Live Fire Range, MRAP Downed Person Rescue, Indoor Multi-Officer Room Clearing, and Oconto County Rescue Task Force with Unified Command and Incorporation

of Fire/EMS Personnel. This is another example of the quality working relationships between all of Oconto County's public service agencies.

On April 13th, I assisted the Gillett Public Library with a Women's Self Defense class held at the Gillett Community Center. I was able to arrange for a colleague friend, and current Crivitz Chief of Police, Troy Ugoretz, to lead the class. Chief Ugoretz is a highly respected leader in the local martial arts community and graciously donated his time to present the class.

The Gillett Police Department hosted the bi-annual National Drug Takeback Day on April 22 from 10am-2pm. Nearly 20lbs of medications was collected. This event is in addition to our daily drug takeback drop box which is located in the police department lobby.

I also have several items related to staffing and officer coverage concerns. During the month of April, deputies with the Oconto County Sheriff's Office and Game Wardens with the Wisconsin Department of Natural Resources, responded to 14 incidents that occurred in the city due to staffing issues. This time of year typically has a lower volume of calls for service with substantial increases moving into the summer months. The current trend is indicating a sharper than normal increase that is occurring earlier in the year than in the past. That being said, I have reached out to Sgt. Jenny Austin with the Wisconsin State Patrol and she will be supplying the city with several of her troopers to assist with all of our large scale summer events. I wish to recognize and thank all of our law enforcement family for the continuing added support as we work through these staffing struggles.
