Public meeting on raising the sewer volume rate from \$4.00 per 1000 gallons to \$5.75.

Highway 22 Project will be very costly to the water and sewer. There will be financing for the project. Utility applied for a clean water fund loan, safe water drinking loan, and USDA. The Utility needs to start saving for this project. State will pay for road and storm, city pays for parking lanes, and the rest is on Utility. We have secured grant money of \$285,000 for sewer. Design for the Highway Project needs to start soon. Water lines have in under the highway since 1926.
