- 3. **Public Input:** Kelly Roberts, manager of the apartments on Robinhood Lane, was concerned of some problems. ATV's going very fast down the road, kids, dogs, and elderly all around the area. Atv's park in the way of apartments designated parking spots.

Theresa Nelson, Chief inspector on election board, concerns of the coming election. Thinking it will be very busy and wanting help with Election Day registrations and wanting more security throughout the day.

- 4. Discussion on Highway 22 Project Information- Shirley Hinze is offering her help on the HWY 22 project. She stated she has the ability to reach out to WIS DOT on our concerns. Utility will go through the year before and need to fix the roads before the highway comes through to do a total reconstruct. Water and sewer department is supposed to lay 7 inches of asphalt, adding \$50-100,000 more for something that gets tore out in less than a year. Asking for 3 inch. WIS DOT wants it done one year ahead of time for trench settlement.

I regret to inform the council that Officer Hoeft has accepted a position with the Oconto County Sheriff's Office. Officer Hoeft will remain with us through most of the month of September. Officer Hoeft's hard work and dedication to this department and the citizens of Gillett has been nothing short of exemplary! He will be missed! Our current part-time Officers, Braun and Kurtz were advised of Officer Hoeft's departure and our both interested in the position. Upon completion of their field training process, both officers will have their performance reviewed for consideration for the position.

Officers Braun is well into her Field Training Program and Officer Kurtz has recently begun her Field Training Program as well. Both officers have been doing well and I'm expecting their solid performance to continue. With the departure of Officer Hoeft, we will be losing a Field Training Officer. Because of this, Officer Hull will be attending Field Training Officer School at FVTC at the end of the month. Officer Hull will be taking over the monthly IBR (Incident Based Reporting) and Use of Force Reports currently handled by Officer Hoeft. These two reporting items are required by state and federal agencies. Officer Hoeft will be assisting in making sure Officer Hull is trained up and ready to assume these roles.

I have updates in regards to the creation of the proposed Gillett School District full-time school resource officer program for the Gillett School District. During the August Gillett School Board Meeting, the SRO program was accepted and the Oconto County Sheriff's Office was selected to provide the School Resource Officer. Earlier in the month of August the Gillett City Council elected to withdraw from consideration for providing the school resource officer. The Gillett School District and the Oconto County

Sheriff's Office will continue establishing the program and hope to see an officer in place sometime in the next few months.

The planning has already begun! The funds raised during the event were donated to the City of Gillett Fire Department.
