For jurisdiction; City officers can only do city, but city officers can go into county if they are required for a follow up. Members asked how many county officers are on at night, 4 on night shift from the county at minimum. Luther stated would like to see a county officer in the Gillett School. Luther asked about who pays for holiday pay, maternity leave, vacation and things like that. Sherriff Skarban feels it could be a great relationship for the city to collaborate with the school. Beyer expressed his approval on moving forward with the position.
